Today the Age Appropriate Design Code (Children's Code) comes into force in the UK. This ground-breaking legislation requires the tech sector to protect children's privacy, safety and wellbeing in products and services likely to be accessed by children and young people under 18.

The Code has prompted changes in areas such as targeted advertising, safe searching, plus the banning of direct messaging from strangers to minors. It mandates stronger age assurance as well as a host of wellbeing measures, with many more changes on the way.

For too long children have been exploited, surveilled and harmed online. The Children's Code shows that technology companies are able to function, even when regulation requires them to protect children. When the government acts, the tech sector can and will change.

It is rare that we are able to write to celebrate, but this is a great day for children and parents, who can look forward to the digital world that they deserve. The Code builds the UK's reputation as the global leader in child online protection and marks a new era of responsibility from the tech industry.
