

Sir Peter Wanless appointed Chair of pioneering charity, 5Rights Foundation

Sir Peter takes this vital role after stepping down from his trailblazing 11-year tenure as CEO of NSPCC, during which the NSPCC became an indispensable voice in child online protection. Under his transformative leadership, the NSPCC has advanced its mission to prevent child abuse, protect children, and transform societal attitudes. Before this, he was Chief Executive of the Big Lottery Fund and was a Director at the UK Department for Education between 1998 and 2008.
